Banca Generali enjoys a privileged position in the industry landscape due to the resilience of its business model, the strength of its capital position, and the stability of its funding and asset portfolio. The capital position proves to be solid despite the volatility of financial markets and the increasing demands associated with business expansion.





THE SOLIDITY OF BANCA GENERALI

Banca Generali belongs to a group with over **190 years of history** and a financial strength rating higher than that of the Italian state. Moody's agency - in fact - has **confirmed at the end of 2023 the A3** rating assigned to the Generali Group, with a **stable outlook**. Today we can offer investment solutions that cannot be replicated by others, thanks to the size and quality of the underlyings, the intelligent management of flows, and the solidity of our Brand.



All the Bank's **capital ratios** are well above regulatory limits and take into account the proposed distribution of a dividend per share of €2.15, which corresponds to a capital distribution equal to 77% of the generated profits.



Funding consists almost entirely of deposits (€13.5 billion, more than 83 percent distributed among the Bank's customers); assets are characterized by about €10.7 billion in the securities portfolio. The loan portfolio is about €2.3 billion mainly consisting of counterguaranteed loans, highly collateralized.



The proprietary portfolio proves to be of high **reliability** and **prudence**, providing stability even during the most turbulent times. The **86 percent** of the portfolio is classified as limited volatility (International Financial Reporting Standards).
