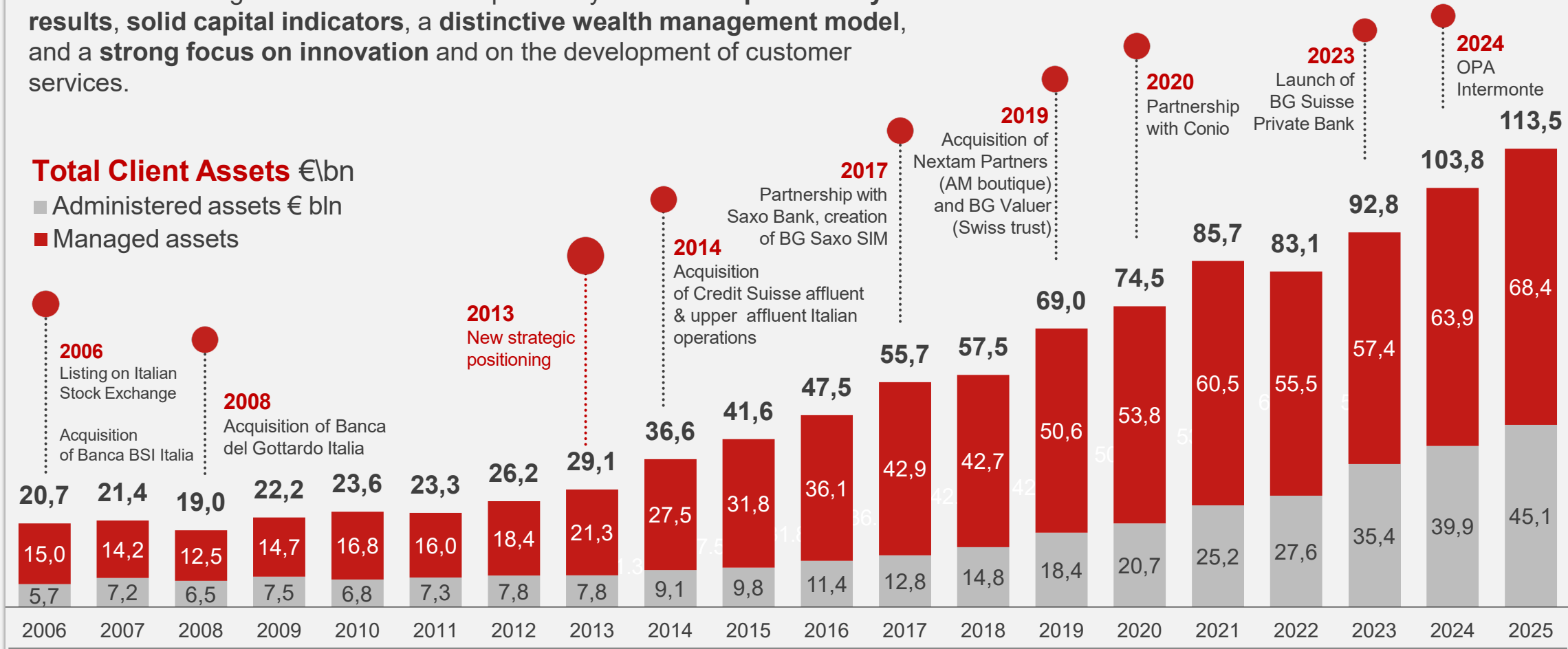

## Total Client Assets €bn

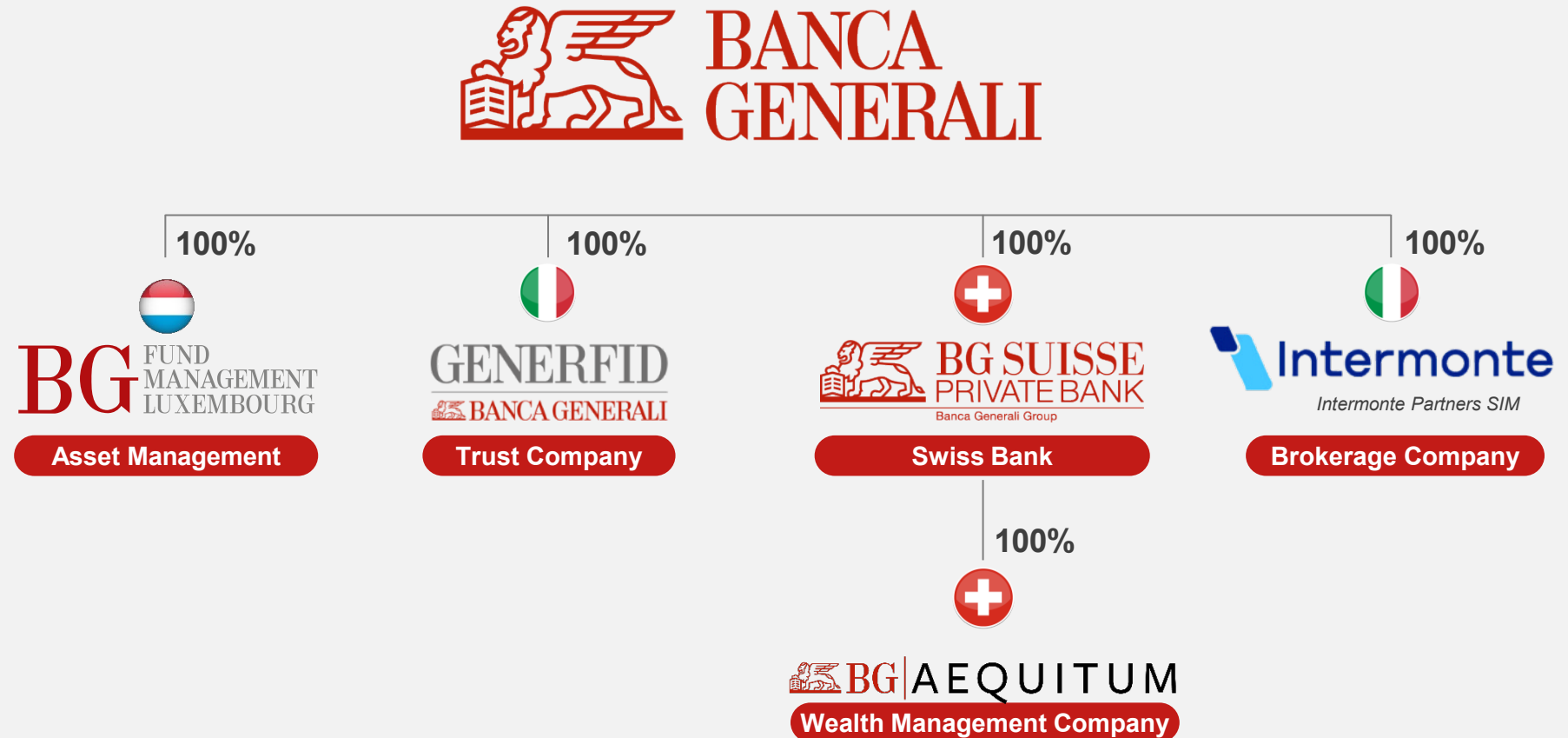

# MARKET APPRECIATION

Since 2006, the stock has significantly outperformed the Italian banking sector, firmly positioning **Banca Generali's shares among the top financial stocks in the national market**. The inclusion in the Stoxx Europe 600 index in December 2024 provided further recognition of its **positioning among the leading European private banks**.

Banca Generali also strengthens its **leadership in sustainability** by entering for the first time the **S&P Dow Jones Best in Class Index (Europe)**, one of the **leading benchmark indices for companies with the best ESG performance in Europe**.

# THE SOLIDITY OF BANCA GENERALI AND COMPARISON WITH THE MARKET

**Banca Generali** enjoys a **privileged position** in the industry landscape due to the **resilience of its business model**, the **strength of its capital position**, and the **stability of its funding and asset portfolio**.

Compared to the market, Banca Generali has historically made limited use of debt to finance its growth and to strengthen its capital position. The debt issued is also entirely underwritten by Assicurazioni Generali (in November 2025, the **Moody's** agency upgraded the **A2 rating assigned to Generali Group**, changing the outlook from positive to stable).

**The financial position proves to be solid and growing**, despite the uncertain economic scenario, also impacted by ongoing geopolitical tensions.



All the **capital ratios** stand at percentages **well above the regulatory requirements** after estimating a **capital distribution equal to 85%** of the consolidated profits generated in the first quarter of 2026.



The funding consists almost entirely of **deposits (€16.2 billion, approximately 86% made up of customer deposits)**. Assets include a **€13 billion securities portfolio** and a **loan portfolio** mainly consisting of highly collateralised, **guaranteed loans**.



The proprietary portfolio shows great **reliability** and **prudence**, where management ensures stability even in times of high turbulence. **74%** of the portfolio is classified as having **limited exposure to volatility** (IFRS).

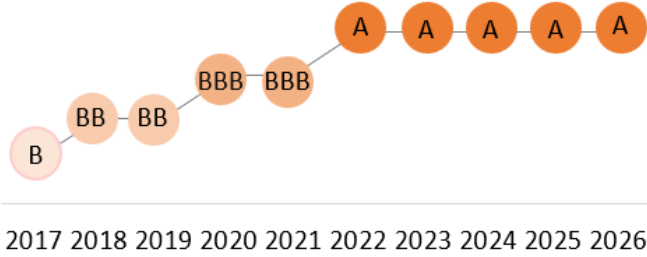

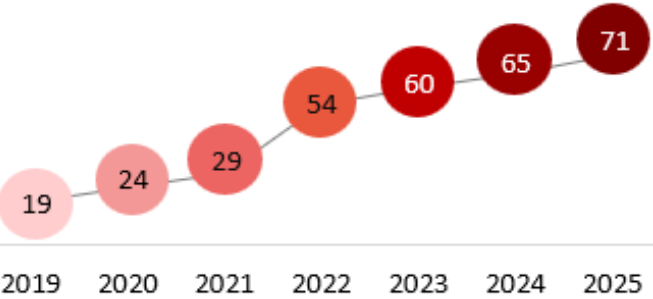

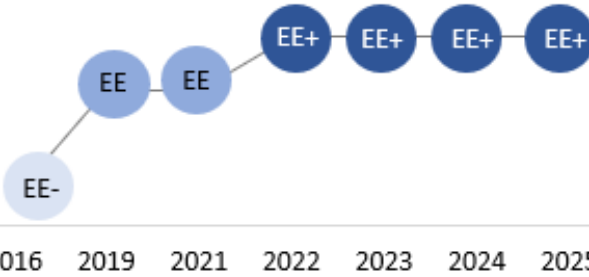
